



Jump & Inflatable Rules

Pre-Operations & Setup Checklist

- ___ 1. Weather conditions must be satisfactory to operate.
No rain, storms, or wind over 15 mph.
- ___ 2. Seams & mesh in good condition.
- ___ 3. Tie down straps in good condition.
- ___ 4. Inflatable ride must be securely anchored.
- ___ 5. Jump entrance safety net in good condition.
- ___ 6. Warning & rule signage in place.
- ___ 7. Entrance & exits are clear of obstructions.
- ___ 8. Blower air pressure is sufficient for inflatable unit.
- ___ 9. No debris or sharp objects in or around inflatable area.
- ___ 10. Jump or inflatable is clear from all power and utility lines. (20 ft).
- ___ 11. Blower is firmly attached to inflatable unit.
- ___ 12. Blower is working and plugged into a GFCI outlet.
- ___ 13. Generator follows all manufactures guidelines for operation.
- ___ 14. Electrical cords are in good condition and pose no hazards.
- ___ 15. All inflatable accessories are clean, and in good condition for use.
- ___ 16. Fencing is secure and in place if required.

Safety Rules For Inflatable Jump, Slides, & Interactive Rides:

1. Supervision by an adult trained attendant is required in attendance at all times.
Minimum number of operators on a inflatable bounce is one (1).
Minimum number of operators on an Inflatable Slide or Interactive is two (2).
2. Attendant shall make all riders aware of safety rules of the inflatable unit.
3. **No** shoes allowed on ride.
4. **No** food, gum or drinks inside Bounce ride.
5. **All** riders must empty all pockets of coins and sharp objects.
6. **All** riders must remove eyeglasses and jewelry before entering the ride.
7. Riders must be grouped according to age and size before entering ride.
Young children shall not ride with older children & adults.
8. Persons with mental or physical impairment should not be permitted on the ride.
9. **No** riders under the age of 3 years old should be permitted without direct supervision from an adult.
10. Entry to the ride should be done in an orderly and controlled manner.
11. **No** flips, wrestling or other forms of rough housing allowed while on ride.
12. Do not bounce closer than four feet from each other.
13. Do not bounce near doorway. Doorway must be kept closed and secured when in use.
14. Do not jump onto or off the Jump or Interactive ride.
15. **No** grabbing or hanging on the outside walls or roof.
16. **No** riders allowed on ride while it is being inflated or deflated.
17. Do not inflate in high winds, (**15 mph**).
18. If during operation the wind becomes excessive (**15 mph**), or it rains, unload riders and deflate the ride.
19. The ride is not to be used when raining or wet. Do not spray water on ride for any reason.
20. **No** silly string, glitters, toys or food of any kind allowed on the ride.
21. Number of riders should be limited according to age and size, and is the responsibility of the adult in charge.
22. Unit must be anchored prior to and during operation.
23. Keep persons away from blowers and electric cords at all times.
24. Persons not following the safety rules should be asked to exit the ride.
25. Persons shall go down slides & obstacle courses feet first, with no more than 2 riders at once.
26. **No** climbing up slides.
27. **No** jumping onto or down slides.

13 x 13 Size Jump

Main Events recommends no more than 5-6 riders at a time 8 years or younger, Adults 3-4.

15 x 15 Size Jump

Main Events recommends no more than 7-8 riders at a time 8 years or younger, Adults 4-5.

All Other Slides or Interactives

Main Events recommends no more than 2 riders at a time 8 years or younger, Adults 2.

Emergency Procedures

1. If blower stops, exit riders as soon as possible in an orderly fashion.
2. If storms or rain starts, exit riders as soon as possible in an orderly fashion.
3. Unplug blower when not in use.
4. Keep riders away from un-inflated unit.
5. Call appropriate emergency responders in case of emergency if necessary.
