



# Dunk Tank Setup & Rules

## Pre-Operations & Setup Checklist

**NOTE:** There is a \$20.00 cleaning charge that will apply to each unit that is not cleaned upon return. All Dunk Tanks must be returned in the SAME condition they were received—THOROUGHLY CLEANED AND READY FOR USE. Please read and follow instructions to avoid additional cleaning charges. Non returned balls will be charged at \$10.00 each.

### **TOWING:**

Fold target wing in against the side of the unit and securely tie off, then slowly tilt tank back onto its wheels. Place seat in it's up position and lock.

Insert hitch tounge and secure with both pins. Attach to tow vehicle and secure safety chains. This will require a 2" ball.

Place target arm, and tennis balls safely in tow vehicle.

### **SETUP:**

Select a level area for setup.

Unhook trailer from tow vehicle and roll to setup area.

Raise tongue end of trailer and remove hitch pins from tongue bar, slide tongue bar out and replace hitch pins to prevent loss.

Slowly lift up and set tank upright. **DO NOT DROP TANK HARD.**

Un-secure the target wing and swing out into position. It may be necessary to block bottom of target wing due to wind.

Check drain plug in place. **DO NOT OVER TIGHTEN.**

Fill with water (approx. 500 gallons).

Place the flattened end of the target arm into the trigger mech, behind the vice grip handle. Put the other end though to tubing in the target backdrop. Insert target into the arm with the clip pin.

Make sure the arm is in the slot on the side of the frame.

Test target so it works properly. Adjustments can be made for the amount of force required with the vice grip adjustment screw.

## **OPERATION:**

- Check to see that the seat is properly locked and the vice grip is released when the target is pressed. Lift seat and latch vice grip prior to setting on seat. Remind Dunkee
- to set forward on the seat and keep hand & arms on their lap.
- **ONLY USE TENNIS BALLS WITH THIS UNIT!!!!!!**  
Monitor water level. Keep full at all times.

## **SAFETY RULES:**

Follow all safety rules! They are for your safety.

1. Adult Supervision required at all times.
2. Keep East Dunker away from electricity.
3. Keep water level filled at least 8" from top of tank.
4. Only one person at a time allowed on seat or in tank.
5. Keep all non swimmers less that 5' tall out of tank.
6. Advise Dunkee to move towards front of tank when coming up out of water to avoid hitting head on the seat.
7. Drain tank when unattended.
8. Use Tennis balls ONLY! **DO NOT USE BASEBALLS!**
9. **NEVER** stand on seat.
10. When on seat, sit forward and keep hands on lap.
11. Do **NOT** hit target with hands, Dunkee may not be ready.
12. Do not operate dunk tank during bad weather, lightning, or a storm.
13. Do not use alcohol or drugs while operating dunk tank.
14. Persons with physical or mental impairment should not be permitted on dunk tank.
15. Maintain water quality by changing water frequently.
16. Call appropriate emergency responders if necessary.
